


QPI Gas Partnership Opportunities

- Since its formation in 2005, QPI has been organized into Upstream, Gas & Power, and Downstream segments
- Multi billion US\$ capital plan is currently focused on upstream, but we are still actively pursuing opportunites worldwide in the Gas & Power, and Downstream segments

- Current portfolio pipeline includes projects that could build supply options for well over [300,000 boe/d] of Qatari gas and gas liquids
- Significant Qatari supply currently available for appropriate projects in Gas & Power and Downstream worldwide
